In accordance with 40 C.F.R. § 257.71(d)(1)(i), Cleco Power LLC (Cleco) submitted to EPA Administrator Wheeler on December 14, 2020 a letter announcing the intention to submit alternate liner demonstrations pursuant to 40 C.F.R. § 257.71(d)(1)(ii) for the bottom ash pond and fly ash pond at Brame Energy Center, located at 275 Rodemacher Road in Lena, Louisiana 71447. Enclosed with the letter was Cleco's application requesting the opportunity to submit alternate liner demonstrations. At this time, Cleco has determined not to submit the alternate liner demonstrations and so is now respectfully requesting to withdraw the application.
